Summary of LoA

The Voluntary Guidelines for Securing Sustainable Small-Scale Fisheries in the Context of Food Security and Poverty Eradication (SSF Guidelines)have been developed through a participatory approach in which civil society organizations played a major role, with the International Collective in Support of Fishworkers (ICSF) as a key driver in this context. Also in the implementation of the SSF Guidelines, small-scale fishers and fish workers, through their organizations, are main drivers of change and play a major role in the "bottom-up" processes"

ICSF reconstituted in 2017 and is now focusing on taking relevant international instruments to influence decision-making processes at subnational, national and regional levels. The goal of the newly-registered ICSF is to strengthen fishery communities comprising men and women in marine and inland fisheries in both developed and developing countries and to influence decision making processes at various levels in a spirit of dialogue, partnership and collaboration. The new phase will complement the completed projects, specifically to educate indigenous youth in Brazil and to revitalize Ghana's national platform of small-scale fisheries stakeholders, but also to social development and small-scale fisheries communities, a particular focus.

Nigeria was added considering that it has the largest population of small-scale fishing communities in Africa, especially to raise awareness about the SSF Guidelines among small-scale fisheries actors and to establish linkages with other small-scale fisheries initiatives in Nigeria that are working in partnership with ICSF at the national and regional level. It is in this context that the Lagos State University will enable small-scale fisheries actors to actively participate and engage in relevant national and regional processes that contribute to securing sustainable small-scale fisheries in the context of the implementation of the SSF Guidelines.

The main objective/output was to strengthen capacity of small-scale fisheries communities at local level in Nigeria to actively engage in securing sustainable small-

scale fisheries in the context of the implementation of the SSF Guidelines. The outcome was to develop capacity of small-scale fishery leaders applying a human rights-based approach; leaders and members of fishworker organizations (FWOs) are educated on human rights standards; and national polices of relevance to small-scale fisheries and fishing communities are influenced through advocacy and the formulation of a draft policy document on SSF.

Funds to achieve the major outcome were provided to the Lagos State University and used to conduct the following activities:

- Consultative engagements with small-scale fisheries stakeholders to develop a draft document on national policy on SSF
- Training and capacity-building of FWOs and SSF leaders to educate their members and align their organizations and communities with the human rights standards
- Develop informational materials and articles to address communication gaps in promoting the SSF Guidelines, including final training and capacity development materials and communication materials for public experience sharing, with pictures, links, quotes etc.

The project was completed over a period of a maximum of Eighteen months after signature of the present Agreement by both parties.

Under the LoA, the following products and activities were delivered and completed, respectively:

- Conducted workshop to create awareness on the importance of SSFs and for the Implementation of the FAO Voluntary Guidelines for Securing Sustainable Small-Scale Fisheries in the Context of Food Security and Poverty Eradication (SSF Guidelines) with a wide range of state and non-state actors particularly the fisher folks.
- 2. Formed two Working Groups and conducted technical sessions to produce a communiqué which has been finalized.
- 3. Conducted capacity building workshop on advocacy for state and non- state actors.
- 4. Produced and submitted a background (synthesis) paper with information on the country case study under Illuminating Hidden Harvests towards incorporating relevant elements of the SSF Guidelines to enhance fisheries governance, food security and poverty reduction in local communities.
- 5. Communication tools including a brochure on small-scale fisheries and the Guidelines in four languages: English, Yoruba, Hausa and Pidgin English; posters, banners and souvenirs T-shirts, notepads and biros, sports bottles, tote bags, cups and caps on the SSF Guidelines and IYAFA 2022 with assistance from FAO Nigeria office. - 6. Workshop Concept Note, detailed agenda and programme for the two workshops and Terms of Reference (ToR) for SSF Working Groups.
- 7. Established Nigeria Small-Scale Fisheries Guidelines Alliance Network.

Issues or challenges you experienced.

- 1. Experienced delayed early buy-in by the Federal Department of Fisheries and Aquaculture in the Ministry of Agriculture and Rural Development, Nigeria into draft policy briefs due to poor communication/ network facilities.
- 2. Delayed release of funds caused rescheduling in planning logistics of participants and other arrangements to host the workshops.
- 3. Several delayed responses from CAOPA caused non-scheduling of a virtual meeting and absence of a representative to participate in the workshops despite sending a formal invitation to the events.

Opportunities that you were able to take advantage of:

- 1. Copies of SSF Guidelines and Card game-GO small-scale fishing were received from the FAO and shared at workshops.
- 2. Engagement with the regional AAG in support of the implementation of the SSF Guidelines for Africa.
- 3. Early engagement with WorldFish (Malaysia and Nigeria) and FAO.
- 4. Contributed to working paper on small-scale fisheries contributions to food and nutrition security in Nigeria led by Kendra Bryd and published by WorldFish, Malaysia. - 1. Follow-up on recommendations of the inaugural meeting of the Small-Scale Fisheries (SSF) Nigeria Guidelines Steering Committee held virtually in September 2022. These recommendations will be taken in piece-meals to enable concrete outputs and outcomes to be achieved.
- 2. Specifically, the Chairman will continue to communicate with the Office of the SSAP- SDGs to follow-up on the implementation of SDGS 2 and 14, respectively and the Fisheries Guidelines Policy Development.
- 3. Continue to use social and local media to amplify communication and outreach.
- 4. Seek collaborations with the institutions that are involved with the issue of fisheries: Nigerian Institute for Oceanography and Marine Research (NIOMR) and Nigerian Institute for Freshwater Fisheries Research (NIFFRI), so that way, no one is left out.
- 5. Documenting advocacy and research activities that have positively impacted smallscale fisheries can aid in the possibility of recommending some of these activities and technologies for scaling up.
